Starting a new treatment brings up a lot of questions. One question may be how you will pay for your medicine. GSK understands how stressful this can be, so we have created the **Together with GSK Oncology** Co-pay Program for eligible, commercially insured patients to help with out-of-pocket costs.



HOW DOES THE CO-PAY PROGRAM WORK?*

- Helps with your cost share up to a total of \$26,000 for up to 12 months*
- Covers up to \$100 per visit toward your cost share for product administration*
- The patient cost share for office visits, labs, and other ancillary services is not included in the Co-pay Program

*If a patient is approved, the Co-pay Program may help with the patient's cost share for the GSK product and the cost of administration, up to \$100 per administration for intravenous products, up to a program total of \$26,000 annually. Residents of Massachusetts, Minnesota, or Rhode Island are not eligible for reimbursement of administration fees. Doctor's office visits, labs, and other ancillary services are not included in the Co-pay Program.

AM I ELIGIBLE?



You may be eligible if you:

- Have a commercial medical or prescription insurance plan OR are uninsured
- Are a resident of the US (including the District of Columbia, Puerto Rico, and the US Virgin Islands)



You are not eligible if you:

- Are covered by any federal or state prescription insurance program, including Medicare Part B, Medicare Part D, Medicaid, Medigap, Veterans Affairs (VA), Department of Defense (DoD) programs, or TRICARE. This may also include state pharmaceutical assistance programs and other federal or state plans not listed
- Are Medicare eligible and enrolled in an employer-sponsored group waiver health plan or government-subsidized prescription drug benefit program for retirees
- Are enrolled in a state or federally funded prescription insurance program. You may not use this program even if you elect to be processed as a cash-paying patient
- Are on Medicare Part D, even if in the coverage gap
- Are enrolled in a commercial health plan that does not permit the use of co-pay assistance programs

HOW DO I APPLY?

You will need to enroll in **Together with GSK Oncology** to find out if you are eligible for the Co-pay Program.

1. Ask your healthcare provider to help you complete the **Together with GSK Oncology** Enrollment Form
2. Your healthcare provider can complete and submit the form online or fax the completed form to **Together with GSK Oncology**
3. **Together with GSK Oncology** will call you within 1 to 2 business days to go over your options for eligibility for the program

Be sure to promptly return any phone calls you receive from **Together with GSK Oncology**.

HOW DO I USE THE CO-PAY PROGRAM?

If you are eligible for the Co-pay Program, you can use the program in 2 ways. You can choose to receive your co-payment on your debit card or you can choose to have your provider receive your co-payment directly from the Co-pay Program. Doctor's office visits, labs, and other ancillary services are not included in the Co-pay Program. Each option is described below:

Option 1



Pay your provider using a debit card provided by the Co-pay Program.

1. **Submit your Explanation of Benefits**

Your insurance plan will send you an Explanation of Benefits (EOB) after each visit. After each treatment, you or your healthcare provider must fax your EOB to **1-844-475-4662. Together with GSK Oncology** will review your EOB for approval.

2. **Receive funds on your debit card**

If your EOB submission is approved, you will receive funds on your card to cover your eligible cost share and administration fee (up to program maximums). We will let you know the amount loaded on your card by mail.

3. **Pay your healthcare provider**

Once the Co-pay Program funds are on your card, you can pay your healthcare provider. Bring your card to your healthcare provider's office to make your payment.

Option 2



Have the Co-pay Program submit your Co-pay Program amounts to your provider via electronic funds transfer (EFT).

1. **Submit your Explanation of Benefits**

Your insurance plan will send an EOB after each visit. Your healthcare provider must fax your EOB to **1-844-475-4662. Together with GSK Oncology** will review your EOB for approval.

2. **Provider receives funds**

If your EOB submission is approved, **Together with GSK Oncology** will electronically transfer Co-pay Program funds to your provider for your eligible cost share and administration fee (up to program maximums). We will let you know the amount transferred to your provider by mail and text (if applicable).
